



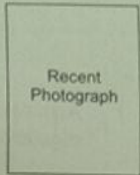

Rules and Regulations

1. Admission is subject to the willingness of the pupil and the parents to comply with requirements and regulations of Ravindra Global Academy.
2. Student whenever they come to school, must wear the prescribed uniform. Those who are not in uniform may be excluded from the class or even sent back home.
3. Irregular attendance, habitual idleness, neglect study assignments, disobedience and disrespect towards the school staff or bad moral influence will lead to dismissal. The pupil are responsible to the authorities for their behavior in or outside the school.
4. Repeated absence without leave, or absence for more than 7 consecutive days will eventually lead to the removal of the pupil's name from the school register.
5. Special arrangements cannot be made for students who are absent from any written/oral examination.
6. Absence/leave in examination will be treated as having no marks received in it.
7. A students who fails twice in the same class will not permitted to continue studies in the school.
8. Any student found to unfair means in any examination will be not allowed to write the rest of the papers and may not be allowed to continue studies in this school in the next session.
9. Students are not permitted to be absent on the closing day/reopening day, or whenever there is a school function or any other special occasion of the school.
10. Students are not allowed to use personal vehicles to come school.
11. Admission is done on the basis of written test and oral test.
12. School fees are to be deposited before the 5th. of every month. A fine of Rs. 20/- per day will be charged for late payments. Without depositing the fee of the month, the pupil will not be allowed classes for the next month. In such cases re-admission charge of Rs. 200/- will have to be paid extra to the fees.
13. The rate of fees are subject to change from time to time due to market inflation and the increase in cost of maintenance and school expenses.
14. Those are seeking admission to class 1st. should be within the age group of 5 and 6 year on 31st. of the years of admission.
15. Parents and students are also bound to follow the rules & regulation which laid down in the 'Student Dairy'
16. If selected for admission, a ward will be allowed to attend class only after depositing the fees and other relevant documents.
17. Our school deals with sexual harassment very strictly, and any such act will be delt with legal authority and punishment will be according to the POCSO ACT. There after he/she will be expelled from the school.
